Currently, the SMF membership stands at about 3,000 members, consisting SMEs, MNCs and affiliate members. Member companies are categorised into 10 Industry Groups and supported by the SMF's Associated Services to address each industry's unique and specific needs and interests.

The SMF collaborates with local and overseas government agencies, industry partners and enterprises to provide key services such as representation of members' views in dialogues with the authorities; increasing business opportunities through local and international trade fairs and missions; building capabilities through conferences, seminars, workshops and other industry-specific programmes; and transforming businesses with business model innovation.

# President's Message

Dear fellow members,

inancial year 2019/2020 has been without doubt an eventful year for many of us. As if the US-China trade conflict, the civil unrest in Hong Kong and the turmoil of Brexit were not enough to pose difficult challenges,

Singapore began its fight against the COVID-19 pandemic as the financial year drew to a close in March. As at the time of writing this message, the pandemic is still sending shock waves throughout the world and our manufacturing sector has also not been spared.

However, we must always draw strength from our achievements of yesterday to overcome the challenges of tomorrow. Hence, let us take stock of our achievements in the past year, identify growth opportunities on the foundations we have built, and, look forward to welcoming the new dawn with courage.

#### **DEVELOPING CAPABILITIES**

The continued development of capabilities lie at the core of the activities the SMF has held in the past year. As one of the bigger Trade Associations and Chambers (TAC) in Singapore, the SMF continuously seeks to reach out to our members effectively and to create relevant programmes to enhance the competitiveness of our manufacturing sector. As events in the world evolved the way of doing business, digitalisation and human capital emerged as

From a survey of our members done in end 2019, the top 3 focal points for transformation are: upgrading workforce skillsets; retraining employees for different functions; and, modernising manufacturing lines for future automation. Separately, a study released by Deloitte in May 2020 notes that, globally, work in manufacturing is poised to transform at an unprecedented pace through the adoption of new technologies like artificial intelligence, advanced robotics, analytics and Internet of Things (IOT). The study also highlights findings that technology is likely to create more jobs than it destroys with the caveat that the challenge will be an ever widening skills mismatch between available workers and the skills required in the jobs that will become available.

In addition, the World Economic Forum (WEF) Future of Jobs Report 2018 stated that by 2022, everyone will require an extra 101 days of learning to deal with emerging jobs that include roles like Data Analysts and Scientists, Al and Machine Learning Specialists, Software and Application Developers and Analysts.

The challenge ahead for our manufacturers is therefore to identify and implement future ready business models and equipment as well as to ready our current workforce for the future through the implementation of effective training and education pathways for both the current workforce and those expansion. This year, the SMF was honoured collaboration with our partners RHB entering the workforce. These are the main reasons why in FY2019/2020 the SMF launched its "Business Re-Modelling Towards Industry 4.0" programme to saw an increase in visits and interactions locally to adapt to the modern consumer, assist member companies on their digital transformation journey; and, signed a MOU with the National University of Singapore's School of Continuing and Lifelong Education to further encourage our members on the journey towards life-long learning.

The SMF also continued to see a strong uptake in our talent development programmes administered by the SMF Centre for Corporate Learning (CCL). For Professionals, Managers and Executives (PMEs) seeking new job placements, the SMF has since assisted more than 2300 PMEs in converting them to a new career. commonplace and will be crucial for a PMEs acquire skill sets for a mid-career switch through programmes like the PCP Broad-Based, Overseas and P-Max. 



# The Singapore Packaging Star Awards 2019

innovative packaging designs won awards at the Singapore Packaging Star Awards 2019 held on 16 August 2019 at

the Singapore Marriott Tang Plaza Hotel. Organised by the SMF's Packaging Council of Singapore Industry Group, the gala dinner and award ceremony was graced by Guestof-Honour, Mr Edwin Tong, Senior Minister of State, Ministry of Law & Ministry of Health.

The Singapore Packaging Star Awards is a prestigious national award that honours companies and students for their innovative and creative packaging designs and material use. The Award has four categories - Commercial Sales & Display, Commercial Environmental Sustainable Packaging, Commercial Transportation & Protection, and Student Sales & Display category. Winners of the Singapore Packaging Star Awards will have the opportunity to gain regional and international acclaim as they will be eligible to compete in the AsiaStar Awards and WorldStar Awards.

This year, out of the 29 awardees, 20 students from different institutes of higher learning were awarded for their packaging designs. Out of these 20 students, three of the students from Ngee Ann Polytechnic went on to represent Singapore at the regional stage, successfully adding the AsiaStar Awards to their collection. By giving a total makeover to cereal boxes, teabag storage and MAGGI® Packaging, they gave conventional product packaging a breath of fresh air, while at the same time keeping in mind the need to keep products fresher for longer.

In the commercial category, two companies received three awards at the local, regional and world stage – the Singapore Packaging Star Awards, AsiaStar Awards, and the WorldStar Awards. Magna International Pte Ltd, who won in the Commercial Environmental Sustainable Packaging Category, showcased a pouch made of mineral stone that will eliminate the use of

conventional anti-corrosion hazardous oil or solvent coatings for all metal substrates for protection against corrosion during storage or shipping. Packaging HUB (S) Pte Ltd, who won in the Commercial Sales & Display Category, put forth an ornately designed chocolate box with 3D art to provide a showcase, the evening also provided unique selling point for the product.

In line with Prime Minister Lee Hsien Loong's 2019 National Day Rally message on moving towards a "zero-waste" nation, the messages from all the speakers at this ceremony focused on sustainable packaging for the next generation to have a greener

# Minister Dialogue Sessions

he SMF organises closed-door ministerial dialogue sessions as a platform for our members to converse directly with ministers and government officials to better understand policies and provide candid feedback on the challenges that the manufacturing industry face at the ground level.

In October last year, the SMF collaborated with Restaurant Association of Singapore (RAS) and Singapore Retailers Association (SRA) to organise a closed-door dialogue session with Senior Parliamentary Secretary of Manpower and Education, Mayor Low Yen Ling at the Tripartite Alliance for Fair and Progressive Employment Practices Office.

This year, the SMF hosted separate dialogue sessions with Minister for Trade and Industry, Mr Chan Chun Sing as well as Minister for Manpower and Second Minister for Home Affairs. Mrs Josephine Teo. Both these sessions were welcomed with a capacity crowd. Held at the SMF building in the months of January and March 2020, these sessions were crucial to our members at a critical time as COVID-19 cases were starting to increase and measures were being put in place to support the economy.

Facilitated by SMF President Mr Douglas Foo, many participants queried the ministers on the plans for the Singapore economy and also used the opportunity to speak to the Ministers on their key concerns for the future of manufacturing. The Ministers on their part spoke freely, outlining the planned approach for the handling of the outbreak. Reassuring attendees that the Government is committed to assist businesses through the upcoming challenges, both ministers spoke of the need to deepen capability and build business resilience to be ready to take advantage of opportunities brought about by the crisis.

# **ITAP 2019**

ndustrial Transformation ASIA-PACIFIC (ITAP), a
HANNOVER MESSE event, is one of Asia-Pacific's
leading trade event for Industry 4.0. Bringing together
an ecosystem of manufacturers, government agencies,
and businesses ranging from multinational corporations (MNC) to
small and medium enterprises (SMEs), the SMF is pleased to be one
of the joint organisers of the Singapore Pavilion at ITAP 2019, which
took place from 22 to 24 October 2019.

A total of 35 local companies showcased their products under the Singapore Pavilion. 21 of these companies were members of the SMF and it was a dazzling show of expertise across varied industries such as robotics, automation, 3D printing, and numerous other solutions on display.

In addition, the 2nd day of the show also saw the opening of the Global Additive Manufacturing Summit, where the Singapore Standards Council (SSC) launched a new technical reference (TR 70) titled "Guidelines on selection criteria for metal additive manufacturing processes". The development of TR 70 was led by representatives from the Ministry of Defence (MINDEF), the Singapore Armed Forces, the National Additive Manufacturing Innovation Cluster (NAMIC), the additive manufacturing industry, and the SMF – Standards Development Organisation (SMF-SDO). It is the first in a series of four TRs that will be progressively launched by the end of 2020, to provide critical requirements and guidelines for the use of additive manufacturing in military and non-military applications in Singapore. The SMF-SDO also had the opportunity to introduce the standards developed for service and industry robots to Senior Minister of State (SMS) for Trade and Industry Dr Koh Poh Koon.

At the show, SMF Secretary-General Dr Ahmad Magad signed a Memorandum of Understanding (MOU) with iSMART Advanced Manufacturing Solutions (iSAMS) consortium as one of its supporting organisations. Through this MOU, the SMF and iSAMS will assist SMEs in the Singapore manufacturing sector embark on their smart manufacturing transformation and provide resources to SME smart manufacturing providers to better serve manufacturers. iSAMS is founded by iPlast 4.0 Pte Ltd, SMT Technology Pte Ltd and Nanyang Polytechnic.

# **MOU Signings**

s part of providing our members an advantage for their businesses through having a good network for collaboration, the SMF signs Memorandums of Understanding (MOU) with various organisations and stakeholders. During this financial year, the SMF signed 17 MOUs with local organisations such as the Singapore Computer Society (SCS), the Singapore Business Federation (SBF) and the National University of Singapore (NUS) as well as overseas organisations.

These MOUs is focused on collaborations in the fields of technological advancements for the manufacturing sector, internationalisation and talent development.



In May 2019, the SMF signed a Memorandum of Intent (MOI) with the SCS where both parties agreed to set up the Tech Advancement Group (Manufacturing Tech Interest Group) within the SMF. The Tech Advancement Group is a joint initiative by the SCS and the SMF and is supported by the Infocomm Media Development Authority (IMDA) of Singapore under the National Tech Skills Accelerator initiative, to improve the tech capabilities of professionals in the manufacturing sector.



In July 2019, the SMF signed a MOU with the NUS School of Continuing and Lifelong Education (SCALE), where both organisations aim to enable professionals to stay relevant with the right knowledge and skills, and be ready for opportunities in the digital economy. We will work together on initiatives and projects that promote thought leadership and lifelong learning.

# SMF ACTS – COVID-19 Response

o help our members navigate the many different government regulations and relief measures in relation to the COVID-19 pandemic, the SMF launched the SMF ACTS initiative to provide a one stop resource in these difficult times.

Under this initiative, the SMF has among other things assisted our members with appeals to government agencies on circuit breaker restrictions, assisted with spare human resource placements, as well as, organised strategic planning workshops, webinars and virtual business pitching sessions. The SMF also provided free hand sanitisers and sold contactless thermometers at cost price to our members.

The SMF ACTS also includes a COVID-19 microsite for easy access to the latest government advisories, support initiatives by the SMF, email and text for weekly updates by the Secretariat, as well as a resource library from the 'Overcoming' series of webinars providing crucial information on labour solutions, legal obligations, and even business matching.



Dialogue Session with SMF Members on the COVID-19 Situation: The SMF held a dialogue session chaired by SMF President Mr Douglas Foo on 12 February 2020 to understand their business needs during the COVID-19 situation. The views from SMF members were forwarded on to Enterprise Singapore which contributed to the formulation of policies in the Singapore Budget 2020 statement.

# **Global Business Groups**

he SMF's Global Business Group (GBG) is committed to assist our members explore opportunities and internationalise their business through participation in trade fairs and business missions. GBG collaborates with Enterprise Singapore, various embassies, foreign chambers of commerce, business councils and other trade associations to develop cross-border relations and generate trade and investment opportunities that capture new market prospects in geographical or alternative industries for our members, creating a presence at the international level and strengthening the global network.

#### **Trade Shows**

In this financial year, the SMF took the lead in organising Singapore Pavilions in 31 domestic and international trade fairs in various countries such as Malaysia, Vietnam, Indonesia, Cambodia, Thailand, Philippines and in Europe to help local manufacturing companies expand their business horizons. A total of 454 local companies participated and generated more than S\$366 million of sales revenue through these trade fairs.

#### **Industrial Transformation ASIA-PACIFIC 2019**

Industrial Transformation ASIA-PACIFIC (ITAP) 2019, is one of Asia-Pacific's leading trade event for Industry 4.0. A flagship trade fair for the SMF, the event attracted a total of 35 companies housed under the Singapore Pavilion, generating a total of S\$43 million in sales by these participating companies. The event brought together various stakeholders to shape and support transformation initiatives, building a strong ecosystem within the industry. ITAP 2019 was held from 22 to 24 October 2019 at the Singapore Expo with an estimate of 412 exhibitors from different regions, showcasing their manufacturing processes, design and production facilities, distribution systems, and global supply chains.

#### Other Notable Trade Shows



SEMICON Southeast Asia 2019 attracted a total of 39 companies under the Singapore Pavilion, with S\$15 million sales generated in the Pavilion. Held from 7 to 9 May 2019 at Kuala Lumpur, it is one of the top-notch trade fairs within Southeast Asia that is dedicated to microelectronics industries including semiconductors, LEDs, MEMs, OLEDs, printed/flexible electronics and other related industries.





The SMF led 25 Singapore companies from the Food and Beverages industry to showcase their new and innovative food products at **THAIFEX** – **World of Food Asia 2019**, which was held in Bangkok, Thailand from 28 May to 1 June 2019. THAIFEX is one of Asia's leading trade show for the Food and Beverages industry. With a total of 2,745 exhibitors from different markets, the show attracted 67,136 visitors from various related industries. Business matching and cooking demonstrations were some of the highlights that were successfully organised for some of our Singapore companies.





Broadcast Asia 2019 was held from 18 to 20 June 2019 at Suntec City, Singapore. It showcased the latest technologies and trends that promise to shape Asia's digital future. A total of 33 Singapore companies exhibited under the Singapore Pavilion and together, they yielded \$\$56 million of sales. It is one of the must-attend international events that brings together some of the largest telecommunication, media and technology professionals. The event had over 1,700 exhibitors and held a series of discussions on issues such as artificial intelligence and cybersecurity.



Held from 2 to 4 July 2019, the SMF and SGTech jointly organised a Singapore Pavilion at the second edition of Interpol World 2019 that housed 24 Singapore companies with \$\frac{5}{25}\$ million worth of sales generated. The event provided a strategic platform to shape global responses to future security threats, through dialogues and exhibitions where companies showcased innovative and cutting-edge technologies. With Interpol's 190 member countries and at least 450 key decision-makers, the exhibition gathered 8,000 trade and professional visitors from international police organisations, law enforcement agencies and corporate security professionals. Held at Putra World Trade Centre, Kuala Lumpur from 15 to 18 July 2019, the fair housed 13 Singapore companies under the Singapore Pavilion, showcasing their latest innovative beauty products and equipment, and generated \$\$7 million in sales revenue. Cosmobeauté is a platform that connects beauty trade professionals within the region to explore business opportunities. Apart from Malaysia, Cosmobeauté is also present in Vietnam and Indonesia.





Held from 9 to 12 September 2019, Australia's leading trade exhibition - Fine Food Australia 2019 connected buyers and sellers within the food services, hospitality and retail industries. 9 Singapore companies were housed under the Singapore Pavilion, generating sales of \$\$770,000. It is a popular event for international buyers sourcing products from the Asia-Pacific region, with over 26,000 visitors across 60 countries. Fine Food Australia welcomed personnel from restaurants, cafes, bars, hotels to bakeries and patisserie. With the diverse audience, it increases brand awareness for Singapore companies' to buyers that are sourcing for new suppliers, new products and innovations.







The SMF led 15 local companies from the Building and Construction industry to showcase the latest building materials and construction equipment at **CamBuild 2019**, which was held in Phnom Penh, Cambodia from 18 to 20 September 2019. Housing over 300 local and international brands, Cambuild provided an international stage where exhibitors found opportunities to grow and connect with international buyers. An equipment display show was successfully organised for Singapore's building and construction companies during this three-day event.





**Tank Storage Asia** is a platform that brings together the Southeast Asian bulk liquid storage industry to discover business and network opportunities. The show was dedicated to both suppliers and manufacturers from across the supply chain in the region. Held at the Marina Bay Sands Expo & Convention Centre, from 25 to 26 September 2019, the SMF housed 14 Singapore companies under the Singapore Pavilion to showcase their latest technologies as well as innovative equipment and services.





Metalex Vietnam 2019 was held from 10 to 12 October 2019 in Ho Chi Minh City, Vietnam. A total of 10 Singapore companies were housed under the Singapore Pavilion, where they showcased innovative metalworking machinery, latest welding technologies and industrial robots. The show was co-located with "Welding Vietnam 2019" and "ROBOT X @ HCMC", attracting over 500 participating brands from local and international companies with their state-of-the-art welding technologies. An estimated 16,000 trade visitors came to this one-stop networking platform dedicated to the metalworking industry.





The medical and healthcare sector met in Düsseldorf from 18 to 21 November 2019 for **Medica 2019**. With a record participation of 5,598 exhibitors from 69 countries, it was the world's largest and leading medical trade fair with 121,369 visitors from 177 countries. 15 Singapore companies showcased an array of innovative medical technologies ranging from Al technology for analysis of neurological disorders to 3D printing to produce implantable devices that enable the body to regenerate tissue such as bone and cartilage.





# Membership and Industry Groups

he SMF, through its Membership and Industry Groups (MEMIG), engages its members via its 10 industry groups (IG) through a myriad of initiatives and activities such as seminars, networking events and dialogue sessions. These activities enhances engagement between members and external parties which includes other federations and government agencies. With constant engagement and outreach, the committee aims to provide members with a conducive platform to network and meet fellow industry peers.

#### **Our Industry Groups**

The SMF's members hail from both manufacturing and manufacturing-related sectors. To address each sector's unique needs and interests, member companies are categorised into the following IGs:

**Building Products and Construction Materials (BPCM)** manufactures, trades and distributes building and construction materials to cater to the construction industry. BPCM IG engages government authorities and statutory boards to ensure a level playing field for Singapore companies. Through collaboration with national organisations such as the Specialists Trade Alliance of Singapore (STAS) and the Institution of Engineers Singapore (IES), the IG champions for the development of the local building & construction materials industry, and for better trading conditions.

Electrical, Electronics and Allied Industries (EEAI) manufactures and supports development and trade in a wide spectrum of electrical and electronics products for use in both consumer and commercial environments. **Energy and Chemicals (E&C)** is a cluster of companies in the oil & gas, power generation and chemicals manufacturing & distribution industries. These companies cover almost the entire spectrum of the petroleum supply chain and include downstream industries such as plastics and paints.

**Food and Beverage (FB)** involves the food & beverage manufacturing and services industries. This IG is instrumental in leading members in dialogues with government agencies and its involvement in various major taskforces has helped lobby for important changes in the food industry. The FB IG has also been successful in listing participating members' products in overseas supermarkets through the SMF's Working in Partnership (WIP) programme.

**Life Sciences (LS)** represents the local generic drug manufacturers and related life sciences trade distributors. The group was established to maintain and enhance the reputation and credibility of the pharmaceutical industry in Singapore. Members meet regularly with the Health Sciences Authority (HSA) to discuss the latest regulatory issues in the region.

Lifestyle (LIG) was officially formed in September 1988 as a result of the merger of the Fashion & Apparel IG, the Jewellery & Watches IG, and the Furniture IG. Today, the LIG acts as the representative voice of the Lifestyle industry, its suppliers and customers. It encompasses sub-sectors from Beauty & Wellness, Entertainment & Enrichment, Fashion & Accessories, Gifts & Novelties, Health & Fitness, Hobbies, to Home & Furnishing products and supporting services. It has also been actively engaging Singapore's Lifestyle industry through various strategic initiatives with its members, partners and government agencies to transform and grow the

Medical Technology (MT) aims to be the leading voice for the medical technology industry in Singapore. The active industry group comprises of top global medical technology multinational companies (MNCs) and local small and medium-sized enterprises (SMEs). MT IG strives to continue building effective relations with government stakeholders and industry partners to move towards a more holistic approach for collaborative opportunities to address the industry concerns in the developments of medical devices to the end users.

Metal, Machinery and Engineering (MME) is a cluster of manufacturing companies that conduct metal fabrication, conventional machining and precision engineering activities. The end products from these MME manufacturers are typically parts which are widely used in the assembly of mechanical systems and

### HSA Closed-Door Dialogue with the SMF Life Sciences Industry Group (LSIG) and the Singapore Association of Pharmaceutical Industry (SAPI) (26 February 2020)

The HSA organised a closed-door dialogue session with the SMF LSIG and the SAPI, which was hosted by HSA CEO, Dr Mimi Choong on 26 February 2020.

During the dialogue session, the HSA shared some updates and new initiatives such as the Australia-Canada-Singapore-Switzerland (ACSS) Consortium and HSA's digital transformation efforts. The objective of the Consortium was to help facilitate the speeding up of the registration process of products in these four countries. Members from both the SMF LSIG and SAPI raised regulatory issues faced by pharmaceutical companies such as the procedures for registration of products with HSA. Dr Choong also gathered feedback from the attendees regarding the impact of the COVID-19 pandemic on the Pharmaceutical Industry. Overall, the attendees found the dialogue session insightful and beneficial to both the industry and regulator.



## **Training**

### Human Factors Engineering Workshop (26 April 2019)

More than 50 participants attended the Human Factors Engineering (HFE) workshop on 26 April 2019. Mr Merrick Kossack, Research Director of Emergo, a UL company, introduced the participants to Usability Engineering (UE) of Software as a Medical Device (SaMD) as the key highlight of HFE 2019, demonstrating the advantages of optimising device design through the application of HFE/UE.

The participants learned about the constitution of SaMD as well as human factors and its relevance to SaMD development. The workshop also covered the way to interpret effectively regulatory guidance, including Medical Device Directive (MDD) and US Food & Drug Administration (FDA) regulations related to SaMD.

At the end of the workshop, the attendees had a better understanding of use-related risk management activities for SaMD and how to better apply Human Factors Engineering process to SaMD. They also learned about the usability testing techniques for SaMD and other considerations when developing SaMD.

#### Workshop on Designing for Compliance to IEC 60601-1 3rd + Amendment 1 Edition (8 May 2019)

The SMF MTIG together with UL International – Singapore Pte Ltd, co-organised a workshop on Designing for Compliance to IEC 60601-1 3rd + Amendment 1 Edition on 8 May 2019.

The UL presenters introduced the electrical safety standard of IEC 60601-1-11 with its structure and global requirements for home healthcare medical devices with a focus on electrical safety protection for these medical devices. The 30 participants at the workshop learned about the awareness of protection against the electrical hazards and how the improved safety for medical devices is applied regardless of whether the medical electrical equipment or medical electrical system is intended for use by a lay operator or by trained healthcare personnel.

## Workshop on Medical Device Software, Life Cycle Process, SaMD consideration and Cybersecurity (29 May 2019)

More than 50 participants attended a one-day seminar on 29 May 2019, to learn more about the IEC 62304 standard for Medical Device software, and, the UL 2900 – a cybersecurity standard. This workshop is timely as software has increasingly enabled advanced functionalities and interaction in medical devices. In addition, software-driven user interfaces, stand-alone software applications, and mobile medical applications are becoming more and more prevalent within the healthcare ecosystem.

At the end of the seminar, the participants had a better understanding of how a combination of the IEC 62304, UL 2900 and the Clinical Evaluation of SaMD are crucial to have a completely effective SaMD life cycle from pre-market to post-market.

#### Accelerating New Businesses in MedTech (30 May 2019)

The SMF MTIG collaborated with A\*STAR to organise a seminar on 30 May 2019 on how A\*ccelerate could be a part of the Medical Technology ecosystem to help SMEs with their needs for current technological capabilities.

Through the seminar, participants learned about Intellectual Property rights and obligations and the importance of protection for intangible intellectual property and the ownership of exclusive rights to these technological properties. Two A\*STAR MedTech start-ups also shared their success stories and best practices with the participants.

#### Jakarta Mission (29 October 2019 to 1 November 2019)

Annually, the SMF PCS IG organises overseas business mission trips to different countries to understand the latest developments in the Packaging Industry and to exchange best practices with overseas companies in the industry. #### **Global Ready Talent**

The SMF continues to be an Approved-In-Principle (AIP) partner of Enterprise Singapore to promote and manage the Global Ready Talent Programme (GRT) that facilities Singaporean/Singapore Permanent Resident undergraduate students from the autonomous universities and polytechnics in Singapore to perform their internships in local companies, particularly SMEs. The programme, formerly known as SME Talent Programme (STP), was enhanced by Enterprise Singapore with effect from 1 April 2019 to include overseas internships (focusing on SEA, China and India) in addition to local internships.

The GRT programme provides 3 types of funding support to help local SMEs attract undergraduate talent from the local IHLs:

- Full-time local internships
- Full-time hybrid (local + overseas) internships
- Full-time overseas internships

For local internships, SMEs can qualify for up to 70% funding support on the internship stipend. For hybrid and overseas internships, besides the funding support for internship stipend by Enterprise Singapore, the IHLs will help fund the travel and subsistence allowance for interns.

#### P-Max Place-and-Train Programme

P-Max @ SMF is a place-and-train programme administered by the SMF and supported by WSG, to assist SMEs to better recruit, train, manage and retain their newly-hired PMETs. It will help newly-hired PMETs to better acclimatise to the new SME work environment and encourage better PMET retention in SMEs.

P-Max @ SMF will also enable SMEs to establish better communication channels between supervisors and staff, and to adopt progressive Human Resource (HR) practices for their newly hired PMETs.

In July 2019, WSG enhanced the P-Max programme by introducing P-Max for Older Worker whereby SMEs that employ Singapore Citizens aged 50 years and above will be able to qualify for an additional S\$5,000 assistance grant besides the one-off S\$5,000 assistance grant given in the standard P-Max programme. In total, a qualifying SME would be able to receive up to S\$10,000 in assistance grants. In addition to the standard workshops for the PMET and the SME supervisor, the SME supervisor would be required to attend a workshop on Age Management to help the company to better manage the older worker.

On 6 February 2020, WSG invited SMF President Mr Douglas Foo and our P-Max team for the CNY appreciation luncheon with the Minister for Manpower and Second Minister for Home Affairs Mrs Josephine Teo, as well as invited the SMF to participate in the minister tour with our PCP participating company, TranZplus Engineering, for our 1,000 placements achievement.

#### Redeployment Professional Conversion Programme

The Professional Conversion Programme (PCP) is a structured Place and Train programme to train mid-career Singaporean or Permanent Resident (PR) PMETs, to take on new job roles while supplying manpower to meet industry and companies' needs.

The SMF CCL has been working with WSG to assist companies in their talent development plans in support of their business operations.

The Redeployment PCP supports employers in their business transformation plans by allowing them to train, reskill and redeploy existing employees (whose jobs are being phased out) into new growth areas within the same companies.

Besides the benefits of having existing employees undergo training and reskilling, companies enjoy a three-month salary support from WSG.

#### Work-Life Grant

The Work-Life Grant (WLG) aims to incentivise companies through funding support to create a work-life harmony environment. It is achieved through the use of flexible work arrangements (FWAs) for all employees.

The Grant comprises both the FWA and Job Sharing incentives, which companies can tap on. Eligible companies can receive funding support up to \$105,000 per company for local employees over two years.

To support companies during the COVID-19 pandemic, the Ministry of Manpower (MOM) announced an enhanced version of the work life grant to enable companies to receive expedited support.

In over a period of less than two months since the announcement from MOM, the SMF has received overwhelming response from interested companies. There were over 2,000 enquiries from the public of which 800 companies were keen to apply and seek clearance for either the existing WLG or enhanced WLG.

# BUSINESS MODEL INNOVATION (BMI) METHODOLOGY IN SMF CENTRE FOR CORPORATE LEARNING (SMF CCL) TRAINING PROGRAMMES

#### **Professional Conversion Programme (PCP) Regional**

Workforce Singapore (WSG) appointed SMF CCL to design and manage this government-funded programme to help mid-career professionals, managers, executives and technicians (PMETs) reskill with the necessary competencies to embark on a career which includes overseas assignments/roles. To enhance the employability of these PMETs, BMI module is incorporated into mentoring sessions. More than 420 PMETs have attended this programme and have benefited from the BMI training and customised topics to suit the PMETs' specific training needs.





PCP Regional mentorship sessions in progress whereby Mentors share their extensive knowledge and experience with participants in key areas such as sales, customer services, marketing, cultural changes, operations management, project management, effective communications, leadership and people management.

#### **Business Modelling towards Digitalisation and Industry 4.0**

This programme is jointly presented by the Manufacturing Alliance comprising the Singapore Manufacturing Federation, SGTech, and Singapore Industrial Automation Association. This programme is approved and funded by SkillsFuture Singapore (SSG). The programme aims to provide participating companies with a good understanding of digitalisation and how Industry 4.0 can generate many different business models.

Under Module 1 "SMEs Go Digital – Digital Project Manager", workshop participants will learn about the common digital solutions available and job redesign required. For the longer term, participants will understand digitalisation – i.e. new business models that can possibly be generated by Industry 4.0, to improve business processes in order to reduce costs as well as create new demands. Workshop participants will have valuable take-away from the training and guidance received.



LEI applications for Singaporean entities are effectively processed by GS1 Singapore and undergo a strict verification procedure to validate the legal existence of an entity against local business registration authorities (e.g. ACRA).

GS1 also provides a free public database of all LEI data that it manages, allowing users access to a valuable set of information when researching entity identification, risk, and exposure. GS1's LEI services enable companies to meet financial regulatory requirements and make smarter, less costly and more reliable decisions about who to do business with.

#### PMC Bond Series – Data Protection and You

# SMF Standards Development Organisation

he SMF Standards Development Organisation (SMF-SDO) is supported by Enterprise Singapore and endorsed by the Singapore Standards Council (SSC), to manage the development, promotion and implementation of standards and to participate in relevant international standardisation activities. To date, the SMF-SDO has established a total of 324 standards and manages 90 active committees across four major sectors - biomedical, food, quality and safety, and manufacturing. The SMF-SDO reaches out to more than 500 active individuals from both public and private sector to contribute their expertise to standardisation in their respective industries.

In FY2019/2020, SMF-SDO has established 62 new standards. SMF-SDO also organised 29 outreach events attended by 3,360 participants to promote standard awareness to the industries.

# First Urban Farm certified with Organic Primary Produce Grown in Urban Environment

SMF-SDO organised a seminar on 11 June 2019, where the first certified recipient of the Singapore Standard 632 (SS 632), Sky Greens Pte Ltd proudly received its certification. This seminar was graced by Minister for the Environment and Water Resources Mr Masagos Zulkifli, and attracted some 64 participants comprising farmers, distributors, retailers, certification bodies and quality assurance personnel.

SS 632 is the world's first national standard for organic primary produce grown in urban and peri-urban environment. It was administered by Enterprise Singapore, developed under the purview of the SSC's Food Standards Committee, and with the support of the SMF-SDO. This Standard (SS 632: 2017 – Organic Primary Produce) incorporates not just organic agriculture principles (i.e. health, ecology, fairness, and care) used in traditional organic farming, peri-urban and urban organic farming, but also address key challenges faced by urban farms in Singapore, which include limited space for agriculture and lack of natural resources like soil and water and higher operating costs due to energy consumption.

# AV forum on Singapore Standards TR 68 in Stuttgart, Germany

The publication of the world's first technical reference for Autonomous Vehicles (AV), TR 68, has attracted international attention. As a follow up to introduce the standard to the world and to collate feedback to further improve the next version of this standards, SMF-SDO organised a full day forum on TR 68 in Stuttgart, Germany on 20 May 2019. This is the first overseas workshop conducted by SMF-SDO and was graced by Mr Laurence Bay, Ambassador of Singapore to Germany. The event was attended by 50 international experts from 26 organisations. Attendees include representatives from Daimler Mobility Services, Federal Ministry of Transport, Germany, Robert Bosch GmbH, Siemens Mobility, Scania and Volkswagen.

# Hosting 38th ISO/TC8 Ships and Marine Technology Plenary Meeting

SMF-SDO played host to the 38th ISO/TC8 Ships and Marine Technology Plenary Meeting in September 2019. This five-day international standard discussion event attracted more than 100 international experts from 20 countries, which includes representatives from China, Norway, Germany, Japan, Korea and United States. Besides fostering Singapore's international relationships with key industry players, Singapore was also involved in the discussion to shape upcoming ISO standards in marine operations (ISO/TC 67/SC7/WG9) and offshore structures (ISO/TC 67/SC7).
