President's Message Dear Fellow Members,

2011 was an eventful year for the world, Singapore, and SMa. Major events, political, economic and natural disasters changed the world. The uncertainties in Europe, Japan and elsewhere in the world affected all of us. Going forward, the year ahead is still uncertain and much depends on macro factors that are beyond our control. We have to ensure that we remain lean and able to respond and react adroitly - and to remain relevant.

At the EOGM held in November 2011, SMa members unanimously approved to change the name of SMa from Singapore Manufacturers' Federation to Singapore Manufacturing Federation, and also to be known as SMF rather than SMa – to better reflect the reality of the Federation as it is; and as it will have to be – transforming itself for the future. The new logo, to be unveiled at the 80th Anniversary Gala Dinner by the Prime Minister, will complete this symbolic transformation.

Members had also approved the changes to the financial year for the annual report at the EOGM. This annual report will cover our activities of the last 15 months (instead of 12 months) from January 2011 to March 2012.

In 2011, SMa was appointed by SPRING Singapore as Standards Development Organisation (SDO) for the development, promotion and implementation of standards for Singapore in the three categories of Biomedical, Food and General Engineering & Safety Standards. This is the first time SPRING has outsourced Standards Development to an association.

One of the main thrust of SMa in the near future is the formation and the funding by the Singapore Government of Singapore Innovation & Productivity Institute (SiPi). This is the first industry-led knowledge enterprise championing manufacturing excellence through innovation and productivity in Singapore. SiPi collaborates closely with the Singapore government agencies, industry experts, academia and overseas institutions to develop tools, case studies and localise best practices and to lead and promote Innovation led Productivity.

Together with our partners Employment and Employability Institute (e2i) and Republic Polytechnic, Silver Productivity was launched in October 2011 by MOS Teo Ser Luck. SMa was the first to initiate a programme to help companies redesign their workplace to increase productivity for the older workers, increasing their employability and providing them with relevant skills.

Together with WDA, we developed a customised innovation and productivity programme called SME Qiang (an abridged version of the WSQ CPI Manager programme) which would benefit many SMEs.

SMa worked with CASE, Singapore Environment Council (SEC) and Singapore Business Advisors & Consultants Council (SBACC) to further extend the use of the GSI barcode for authentication purposes.

With our partners, Tampines Centre CCC, Northeast CDC and Murdoch University, SMa Institute of Higher Learning will contribute a \$350,000 sponsorship to support nine needy students for a period of three years each.

These are but a few of the many touch points that the Federation has developed in 2011.

Meanwhile, our various Centres of Excellence like CCL and EDC as well as our membership services and our Global Business Group have been very active in helping our members improve their business and explore new business opportunities overseas. We have organised numerous trade missions, exhibitions, business trips, seminars and networking events for our members. This is part of the membership services which SMa continues to value add to our members for the last 80 years since its inception in 1932.

#### **80th Anniversary**

2012 is our 80th Anniversary and we have lined up a series of events to commemorate this momentous occasion.

We were honoured to have President Tony Tan Keng Yam unveil our official orchid named 'Ascocenda SMF 80th Anniversary' on 27 January 2012.

This orchid was specially chosen for its solid, long-lasting qualities. The burgundy colour of the orchid symbolises noble spirit, maturity and stability of the Federation. The cluster of flowers at the top of the stalk represents the Federation as one body and the flowers represent the various Centres of Excellence and the various Industry Groups. The dots represent the various Sub-Groups of industries.

We had a fundraising golf tournament in July to raise bursary funds for the staff and family of SMa members to pursue a higher education with SMa Institute of Higher Learning. SMa is also in the midst of producing the 80th anniversary commemorative book and a new corporate video.

The climax of the celebration is our 80th Anniversary Gala dinner on 29 September 2012 with Guest-of-Honour Prime Minister Lee Hsien Loong who will unveil the new Federation logo that evening.

I thank all of you members, partners and friends for your continued membership and support leading us to this success for 80 years.

We are committed in creating and adding value for SMa, the members, the community as well as the country.

I look forward to your continued support and to working even closer with you. Wishing all of you every success and happiness.



Business Missions and Exhibitions
In July 2011, the Vice Presidents of the SMa,
Mr Poh Choon Ann and Mr Simon Li, led the
Singapore Delegation on a business mission to
the China Shandong Province, visiting cities like
Qingdao and Rizhao. In September 2011, Mr Li
spearheaded a trip to Tangshan and Tianjin EcoCity whereas a business mission at the end of the
year saw the Delegation heading to Shandong Kenli
and Weifang.

#### ASEAN, Australasia and Oceania Business Group Courtesy Calls

Under the chairmanship of EXCO Member, Mr Low Beng Tin, the Group was active in organising various outgoing business missions, incoming delegations, factory visits, seminars and meetings for members. It also arranged for VIPs to meet the SMa President for discussions. One of these was the courtesy call to SMa by the Ambassador of the Democratic Republic of Timor-Leste, His Excellency Roberto Sarmento de Oliveira Soares, on 8 September 2011. SMa President Mr George Huang also met with His Excellency Nopadol Gunavibool, Ambassador of Thailand, during a lunch meeting held on 5 October 2011. Mr Low also led a 150-strong member delegation to visit Iskandar in Malaysia.

#### Americas Business Group Seminars/Networking Sessions

In October 2011, the group organised for a high-level Argentinean delegation to have a networking session with its companies. Hosted by the Vice President of SMa Mr Poh Choon Ann, the dinner that followed was attended by the Governor of the Province of Córdoba Mr Juan Schiaretti. A business seminar was also held in conjunction with the networking initiative.

### **Europe Business Group**Incoming Delegation and Business Calls

On 6 October 2011, a courtesy call to the SMa was made by the President of the French Chamber of Commerce in Madagascar. Further, officials from Saarland, Germany, made a courtesy call to the SMa on 18 November 2011. Many talks and seminars were also organised.

#### India, Middle East, Africa and Central Asia Business Group Seminars/Networking Sessions

This group actively holds business seminars for its companies, like the "Uzbekistan: Your Gateway to Business and Investment Opportunities in Central Asia", "Business Opportunities for Manufacturers in Sri Lanka'' and the Business Opportunities for Manufacturers in Israel" in 2011. The group also co-organised a networking session in February 2012 with the Pakistan High Commission at His Excellency Syed Hasan Javed's residence. The more than 50-strong crowd was made up of SMa members and Pakistani businessmen, who enjoyed a presentation by His Excellency, as well as Ms Ayla Majeed, the Director of the Islamabad Stock Exchange and Mr Azeem M. Azimuddin, Managing Director of FTXS Pte Ltd.

#### **Trade Fairs**

In May 2011, GBG put up Singapore's first country pavilion in IMDEX Asia, the Asia Pacific's only dedicated international maritime defence show. In October, it also led a Singapore Pavilion of 22 companies during the three-day Fire & Disaster Asia 2011, a reputable event that emphasises the importance of implementing disaster prevention measures. The Vietnam Oil & Gas 2011 fair that happened in the same month saw a great turnout and was attended by Ms Nguyen Thi Doan, the

Vice President of Vietnam.

Later that year, GBG participated in the Asia Smart Grid, which provided cutting-edge insight into the latest industry developments, as well as a showcase of new products, technologies and services. From 5 to 8 March 2012, a Singapore Pavilion was organised for Defense & Security Asia 2012, one of the leading military shows in the ASEAN region with a record of over 300 exhibitors from 38 countries. All these initiatives by GBG have successfully given Singapore companies great platforms on which to promote their products and services overseas. Overall, GBG organised over 50 trade exhibitions.

## Health, Safety, Security & Environment Function Committee

The Health, Safety, Security & Environment Function Committee (HSSE FC) promotes health, safety, security and environmental practices and standards across manufacturing industries. It promotes and encourages development in HSSE by organising dialogue sessions, seminars and training in conjunction with relevant government agencies, associations and industry experts. #### WSH Awards Convention for Manufacturing 2011

SMa played a part in organising the WSH Awards Convention for Manufacturing, which occurred on 19 May 2011 and was attended by 160 delegates. SMa also promoted the best practices and technologies for improving environmental and occupational health and safety across the manufacturing sectors to raise the WSH standards in Singapore.

#### **Singapore Environmental Achievement Awards (SEAA)**

The SEAA presentation ceremony organised by the Singapore Environment Council and SMa was held at the Shangri-La Hotel and attended by the Minister for the Environment and Water Resources, Dr Vivian Balakrishnan. This annual event recognises corporate leadership and the commitment of companies who successfully marry environmental conservation with sustainable development through their business strategy and practices. It aims to inspire Singapore-based companies to commit to the protection of the natural environment, and encourages them to be transparent about the economic results of their activities.

#### **National Safety & Security Watch Group Award Ceremony cum Symposium**

Held at the Pan Pacific Hotel on 18 November 2011, the event saw DPM Teo Chee Hean and the SMa President, Mr George Huang launching the Manufacturing Industry Safety Security Watch Group (iSSWG), which will serve as a platform for the Home Team to engage the manufacturing industry on safety and security issues.

Officiated by HSSE FC Chairman Mr Birch Sio, the enriching trail organised by SMa aimed to promote health and well-being amongst staff in manufacturing companies and was attended by 133 nature enthusiasts.


